I have an opportunity, March 4-15, to join the McDonald Road Church's youth mission trip to Holbrook Indian School. "Holbrook Indian School is a Christian boarding academy operated by the Seventh-day Adventist Church for Native American youth."¹ These children come from such isolated parts of Arizona that for many it is their best educational option. The school is a K-12 facility which means some start dorm life at the tender age of six!

Here are just a few things we will be seeking while ministering to these students:

1. To draw closer to God through serving them and experiencing life in a culture that is foreign to us.
2. To demonstrate God's love for them through our kindness, care and service.
3. To help remodel an old dormitory into a classroom facility.
4. To lead out in a week of spiritual emphasis.

I am excited about what God is about to do in my life and in other's through this ministry. I do, however, need your help. We will be bussing to Holbrook, Arizona and back. The cost for my transportation, food, housing, construction supplies, insurance etc. comes to about \$700 dollars. However, thanks to some leftover funds from last year's trip and some generous donors, I can go for much less. However, I still need to raise \$350. Do you think you could help me raise this amount?
